

# PRESS RELEASE: The Europe Challenge announces 55 libraries and communities from 24 countries for its 2024 edition

20 December 2023

The Europe Challenge, initiated by the <u>European Cultural Foundation (ECF)</u> and supported by <u>Fondazione Cariplo</u>, the <u>Scottish Library and Information Council</u> and by public funding through <u>Arts Council England</u>, is proud to announce that 55 libraries and communities from 24 countries have been selected for its 2024 edition: *Libraries, Communities and Democracy*. This new edition of the programme addresses various challenges facing Europe, such as social isolation, inequality, disinformation, and the climate crisis, through community-led local change facilitated by libraries all over Europe. The programme will run from January to September 2024.

The Europe Challenge open call invited libraries and their communities to propose creative solutions that enhance democratic participation and social and environmental well-being. 126 applications were received from 28 countries, making it the most extensive application round since the programme's inception in 2020. The 2024 edition marks the programme's expansion to 10 new countries, including Ireland, Georgia, Romania, Sweden, and Croatia.

The selected initiatives of the 2024 cohort of the Europe Challenge tackle a wide range of issues that rethink the roles of libraries as beacons of European democracy. Examples of selected projects include ending the stigma around accessing mental health services, supporting women victims of violence, providing resources for marginalised communities with the issue of debt, revamping libraries as climate gardens during heatwaves, addressing low voter turnout amongst young people, supporting Ukrainian families experiencing trauma during the war, inclusion of refugees, and much more.

"Libraries are more than just houses for books; they are the lifeblood of European communities. They provide safe spaces, foster education, combat social inequalities, and build resilient societies. Recently, libraries across Europe are facing closure, attacks from extremists, and censorship. The Europe Challenge is on the frontline of breathing new life into European libraries. I am excited to see so many communities and libraries across Europe taking creative action to solve challenges and improve social and environmental well-being," said André Wilkens, Director of the European Cultural Foundation.

### **Next Steps**

The libraries and communities we have selected for 2024 will commence their projects in January 2024 and run them until September 2024. During that period, they will participate in a series of online and offline skills development and mentoring sessions, as well as peer-to-peer exchanges facilitated by the programme delivery partners: <u>Including Society</u>, <u>Changency</u>, <u>DOKK1 Aarhus Public</u> Libraries, <u>Public Libraries 2030</u> and <u>OBA Public Libraries Amsterdam</u>.
